### Details:

The deadline to sign up is August 1, 2025, and space is limited. Exhibitors will be listed by the name listed on the registration form with the description provided. There will be 7'x 8' exhibit spaces available. Exhibitors will be provided with a six (6) foot table, two chairs and a white table cloth. The back door for exhibitor registration and set-up will open at 8 a.m. Set-up is from 8 to 9:15 a.m. The main doors will open to the public at 9:30 a.m. Workshops will begin at 10 a.m. Boxed lunches will be served from 11 a.m. through 1 p.m. Each exhibitor will receive two (2) boxed lunches. Exhibitors are expected to keep their exhibit open until the 2 p.m. close of the Fair. Breakdown and clearing of the exhibit area will be completed by 3 p.m. Trash bins will be available at break-down time. WiFi will be available via the school's non-secured network.

### Restrictions:

Exhibitors may demonstrate products and provide educational information and materials, but there will be no on-site sale of products or materials. Exhibitors may offer snacks, prizes or giveaways at their exhibit table. No multi-level marketing or network marketing products are permitted. Also, no religious or political campaign groups will be allowed. Exhibitors must be currently providing services in Tolland County in some capacity (though need not be headquartered here).
